Pupils who qualified for free school meals (FSM) or who received FSM in the last six years were eligible for the pupil premium, worth £1320 per pupil (financial year 2015-16). Pupils in care (Looked After Children) and pupils who were adopted received £1900. Pupils of service families received £300. Schools are responsible for the allocation of the funding to specific projects and interventions.

# Summary of Outcomes 2015/2016 Measuring the impact of PPG spending:

- Teaching Assistant support enabled focus children to receive additional daily support within main classroom teaching activities.
- Teaching Assistant support enabled focus children to attend regular intervention/booster session in reading, writing and maths. TA support enabled Teachers to work one to one or in small groups during lessons with the focus children.
- Support enabled focus PP child in year 6 to make above average progress in reading (+2.74) and maths (+0.67) over KS2.
- Support enabled the 2 focus PP children in year 2 to attain the expected standard in both reading and maths.
- All PP children made progress over time (Sept 15-July 16).

  Maths = 87% of PP children made expected progress, 40% better than expected progress.

  Reading = 87% of PP children made expected progress, 47% better than expected progress.

  Writing = 80% of PP children made expected progress, 53% better than expected progress.
- All PP children were able to access all curriculum enhancement activities on offer from the school – these included: residential trip (Y6 only) termly trips to local museums, exhibitions and workshops, theatre trips, in-school workshops.

- All PP children made progress over time (Sept 16-July 17).

Maths = 89% of PP children made expected progress, 56% better than expected progress. Reading = 88% of PP children made expected progress, 47% better than expected progress. Writing = 83% of PP children made expected progress, 56% better than expected progress.

- All PP children were able to access all curriculum enhancement activities on offer from the school – these included: residential trip (Y6 only) termly trips to local museums, exhibitions and workshops, theatre trips, in-school workshops, Curriculum Enhancement Days.
- All PP children were given the opportunity to attend after school clubs for at least one half term free of charge. Over 75% took up this offer.
- Some PP children were able to use funding to subsidise peripatetic music lessons in order to continue for the whole year.

- All PP children made progress over time (Sept 17-July 18).
- Maths = 86% of PP children made expected progress, 14% better than expected progress. Reading = 90% of PP children made expected progress, 5% better than expected progress. Writing = 90% of PP children made expected progress, 19% better than expected progress.
- All PP children were able to access all curriculum enhancement activities on offer from the school – these included: residential trip (Y6 only) termly trips to local museums, exhibitions and workshops, theatre trips, in-school workshops, Curriculum Enhancement Days.
- All PP children were given the opportunity to attend after school clubs for at least one half term free of charge. Over 80% took up this offer.
- PP children were able to attend up to 2 weeks of free holiday clubs.
